Permitee assumes any and all risks. If any claim arises out of the foregoing, Permitee shall defend, indemnify, and hold harmless Permitors from same.

Indemnification and Hold Harmless: Permitee further agrees to indemnify and hold harmless Permitors against all losses, damages, monetary awards and expenses, including all costs and attorney's fees incurred in connection with any and all claims of negligence on the part of any Permitor brought by Permitee, their heirs, successors, assigns, and legal representatives, for any injury, death, illness, disease or damage to property, arising from or connected with participation in the Volunteer event. The indemnification and hold harmless agreement does not include losses, damages, monetary awards and expenses as a result of intentional, grossly reckless acts of Permitors.
